

# SCHOOL DISCIPLINARY RULES

## Merahan Code of Conduct

This is a set of expectations/rules intended to nurture Merahans to be ready for school and life beyond school. In both word and deed, Merahans are expected to demonstrate the following values:

- a. Respect for the code of conduct. All students should seek to understand the rationale for the expectations/ rules. All students must abide by the expectations/ rules.
- b. Integrity in behaviour and action. All students must face up to the disciplinary consequences to correct their actions, should they violate the code of conduct.
- c. Self-discipline. All students must regulate their own behaviour and actions, according to the code of conduct.
- d. Empathy. All students must conduct themselves in ways that promote physical, social, emotional and mental well-being of others.

### 1. School Image and Representation

- a. The school has sole discretion in determining what will be appropriate representation of the school's name, image, logo and uniform.
- b. Students should not
  - i. Use the name, image, logo and uniform of the school in a way that disparages the school in any circulatory media (e.g. social media, video, print).
  - ii. Disseminate disparaging information and images of school staff and students in any circulatory media (e.g. social media, video, print).

### 2. Respect for the Country

The flag raising ceremony reminds every student that they are a valuable member of the school, community and country. To start the day right, the following is to be adhered to:

- a. All students should be respectful and stand at attention when the national anthem is played.
- b. Students who are Singapore citizens must sing the National Anthem and take the Pledge.
- c. Students will take the Pledge with the right fist placed over the heart.

### 3. School Uniform

The uniform and other prescribed attire are reminders of the common space the school strives to create for students. The following is to be adhered to:

- a. Students are to wear the prescribed school uniform. Modification to the uniform is not allowed.
  - PE attire must be worn during PE lessons.

- b. Students are to wear school-appropriate socks and shoes (e.g. canvas, sports) that uphold the image and reputation of the school. These should be free of potentially offensive words, slogans, logos, pictures and/or cartoons.
- c. Students must not wear accessories (e.g. coloured contact lenses, bracelets, rings) or make-up while in uniform.
  - Only girls are allowed to wear one pair of plain, identical ear studs at the ear lobes.

#### 4. Grooming/ Appearance

The way students present themselves in terms of physical appearance in school and in public has a direct impact on the image of themselves, their families and the school. The following is to be adhered to:

- a. All students are to be tidy and presentable in appearance.
- b. Nails must short and not be varnished or coloured.
- c. Hair must not be permed or dyed.
- d. Male students must be clean shaven and neat in appearance.
  - Hair at the back should not touch the shirt collar. Hair at the front should be above the eye-brows. Hair at the sides should not touch the ears. Hair at the crown should not be too bushy.
- e. Female students with hair longer than shoulder length must have it neatly tied up. Fringes beyond the eye-brows should be pinned up or tucked behind the ears.

#### 5. Behaviour/Conduct

The way students conduct themselves in school and in public has a direct impact on themselves (e.g. educational progression, personal safety), their peers (e.g. safety and security) and the image of the school. The following is to be adhered to:

### Attendance

- a. Students are to be present for all core curricular (e.g. lessons) and co-curricular programmes (e.g. CCA, Merahan Olympics Day, Heart x Sole Challenge, post-exam activities) and school functions (e.g. Speech Day) at the assigned venues.
- b. Absences from school must be supported by valid reasons, defined as follows:

- c. Students with prolonged absences without valid reasons will face disciplinary consequences [refer to page 16].

### Punctuality

- a. Students will be deemed 'late' if they arrive in school after 0730h.
- b. Students who arrive in school after 0730h must report to Operations Manager or the discipline committee for attendance taking. They will be issued a late-coming slip, to be submitted to the subject teacher, before they can access the lesson venue.
- c. Repeated late-comers will face disciplinary consequences [refer to page 17]. This will have an impact on the selection process for academic-related, CCA-related and Edusave-related awards.

### Readiness to learn

- a. Students are to bring all their learning resources required for each day.
- b. All assigned homework is to be completed by the due date and submitted to the teachers
- c. Students are to be respectful. They should not use vulgarity or offensive words and/or actions that hurt others and/or damage properties.
- d. Students are to have integrity. They should not engage in any deceitful acts (e.g. cheating, forgery, lies).
- e. Students are to have self-discipline and empathy. They should not be a disturbance to their peers and staff of the school.
- f. Students who engage in deceitful and disruptive actions during the conduct of assessments (e.g. WAs, examinations) will face disciplinary consequences [refer to page 20].

### Civic consciousness/graciousness

- a. Students are to queue up in the canteen to buy their food/drinks.
- b. Students are to return the utensils to the designated receptacles after eating/drinking.
- c. All parts of the school premises are to be kept clean at all times.
  - i. Littering is an offence.
  - ii. All food/drinks must be consumed within the canteen; unless permission is granted by the school/staff to do otherwise.

- d. Students are to protect public property. They should report incidents where school property is damaged or defaced.

### Safety and security

- a. Students can leave the venue of instruction only if permission is granted by the teacher.
- b. Students who wish to leave the school during school hours for valid reasons (e.g. unwell, medical appointments) must inform the Form Teacher/ Year Head before reporting to the General Office. They will only be allowed to leave the school after approval is provided by the parent/ guardian.
- c. Smoking, vaping, substance abuse, theft and gangsterism are serious offences. Engagement in these activities will result in disciplinary actions and/or referral to the official authorities for further actions.

## **6. Responsible Use of Electronic and Digital Devices and Wireless Network**

Technology can be both a blessing and a curse, depending on how the users are tapping on it. Students are expected to use electronic and digital devices responsibly at all times.

### Electronic devices (e.g. mobile phones, personal learning devices)

- a. Refrain from using all electronic and digital devices during curriculum lessons and school programmes (e.g. assembly, CCA, Heart x Sole) and functions (e.g. Speech Day); unless permission is granted by the school/staff to do otherwise.
  - Parents/ guardians who need to contact your child/charge during curriculum hours can call the General Office at 64748934.
- b. Respect the privacy of students and staff. Students must not use the devices to record/ video/ take pictures of others and/or circulate these without permission.
- c. Creation or transmission of any image, data or other material which is offensive, defamatory, obscene, indecent or that may offend human dignity, including gender, race, culture or religious beliefs.
- d. Users of personal learning devices (PLD) are expected to abide by the PLD – Acceptable Use Policy (AUP) Agreement in subsequent pages.

### Use of the school's wireless network

- a. Access to the network is meant only for authorised individuals.
- b. Users must not
  - i. Tap on network resources, connect equipment or services or software to the network to spam and/or spread viruses, hoaxes and other programmes that can damage or disturb other people or services available on the school's wireless network.
  - ii. Damage, destroy, attempt to gain unauthorised access to data or violate the privacy of other users, including interception or disclosure of passwords, and other sensitive 'personal data' as defined by the laws on the protection of privacy.
  - iii. Carry out any other activity prohibited by Singapore Law, by the International rules, regulations and practices ('Netiquette') of use of other networks and of network services that may be accessed.
